

# SNOWSEEKERS SKI TRIP REGISTRATION

May 1, 2022-April 30, 2023



**Registration:** You will be officially registered on a trip(s) after receipt of your first non-refundable deposit, completion of all forms (membership, waiver, trip registration forms), and your payment of club dues. Registration on a trip(s), or the waiting list, will be on a first come, first served basis.

**Payment Schedule:** The balance due on trips must be paid according to the published payment schedule, or earlier if necessary for contract purposes. Final payment is to be paid no later than the November 15 date. Anyone failing to make payments according to the published payment schedule is subject to being removed or replaced. Prior to being removed or replaced you will be contacted by phone or email and given seven (7) days to bring your payments up to date.

**Waiting List:** Your name will be placed on the waiting list when the annual dues and all fully completed forms (see above) have been received. Trip deposits may be required when being placed on a waiting list. If you do not become officially registered for any trip(s), any deposit(s), less any unrecoverable costs incurred by Snowseekers, will be refunded. The waiting list of people eligible for a trip(s) will be contacted in order of their registration date. If you cannot be contacted at your last known contact information (phone or e-mail), the next person on the list will be contacted. Once placed on the trip(s), the person(s) will assume the full responsibilities of the trip(s) arrangements.

**Trip Cancellation:** To cancel from a trip(s) you must contact the Trip Coordinator. Cancellation notice may be given by phone, email, or written notice. Anyone who cancels a trip(s) may incur a charge for personal costs which may include lodging, ground transportation, lift tickets, airfare, and miscellaneous trip costs.

Refunds for cancellation of a ski trip, when cancelled by the Snowseekers Ski Club, will be paid subject to any penalties incurred by the Snowseekers Ski Club.

**Snowseekers Ski Club-Priority Lodging Policy:**

Unless otherwise agreed upon by all lodging parties, couples have first priority for rooms with a King bed. Singles will be housed in rooms with twin, or two other types of beds.

**Travel Interruption Coverage:** Information about Trip Interruption Insurance, applicable for the Western ski trip, is available upon request (contact the Trip Coordinator).
