

# SNOWSEEKERS SKI CLUB WAIVER FOR DEVIL'S HEAD

I/We, \_\_\_\_\_, hereby waive and release Snowseekers Ski Club, Sports America Tours, Inc., and their officers, agents, representatives and employees, and any other business or person connected with said trips such as lodging, transportation, chaperons, trip leader or otherwise, their respective heirs, personal representatives, successors and assigns from any and all claims for injuries or damages or otherwise, which may arise for any reason whatsoever as a result of my participation in the Snowseekers Ski Club ski trips, and any/all official or unofficial events sponsored by the Snowseekers Ski Club occurring between May 1, 2023 and April 30, 2024.

I acknowledge that I am solely responsible for the condition of my own personal well being and health, transportation, lodging, ski/snowboard equipment, baggage, and personal effects.

In the event of storm, inclement weather, acts of God, COVID-19, vehicle malfunction or breakdown, strikes, work stoppages, or other causes of events beyond the control of Snowseekers Ski Club I shall be responsible and pay for all costs, charges and expenses arising out of, but not limited to, charges imposed by carriers, lodging management, ski areas, equipment rentals, and any other miscellaneous charges.

I know that bare spots, variation in snow, stumps, forest growth, debris, rocks, and many other hazards or obstacles, marked or unmarked, exist within any ski area. I assume the dangers involved and waive the Snowseekers Ski Club of any liability whatsoever for the conditions of the ski area.

All participants on the Snowseeker Devil' Head trip must complete this waiver including those not skiing. Snowseekers group lift tickets are not to be sold or given to any person other than a Snowseekers member in good standing. No liability is assumed for anyone who does not abide by this rule.

I also understand and agree that no discounted trip prices for lift tickets or extra trip activities will be available to anyone using any alternative lodging during the scheduled trip time, or in the same ski area of a scheduled Snowseekers ski trip. This rule applies unless the trip is filled and/or there are no penalties to be incurred by the Snowseekers Ski Club. All trip details and payments must be approved by the Trip Coordinator.

I acknowledge that skiing/snowboarding is a dangerous sport that can result in injury or death. The Snowseekers Ski Club recommends the use of safety equipment at all times. This includes, but is not limited to, helmets, goggles and proper skis/snowboards and approved binding settings. Failure to use any recommended safety equipment is at my discretion. I, and my heirs, agree to indemnify and hold harmless Snowseekers Ski Club in the event of any accidental injury, or death, as a result of my failure to use proper safety equipment.
